After reviewing the operating revenues for 2021, your board of directors approved to set aside \$1,692,154.42. These margins, retained as patronage capital, will be used to help keep the cooperative financially sound and the quality of service as high as possible. The funds will also be used to retire debt and build equity in the co-op's distribution system. The board of directors will retire—or pay—those funds when the cooperative's financial condition permits.

Your cooperative is always there with you, reinvesting in your community. That's why in an electric co-op, the people have the power.
