Your board of directors has elected to set aside \$2,881,060.60 in excess margins for 2022. These margins, retained as patronage capital, will be used to help keep the electric co-op financially sound and the quality of service as high as possible—to retire debt and build equity in the co-op's distribution system. The board of directors will retire, or pay, those funds when the co-op's financial condition permits.

This year, your cooperative paid back \$1,151,463.21 in patronage for a portion of 2004 and 2005, in addition to a portion from Corn Belt Power Cooperative, our wholesale power supplier.
